FIRST: Their names and residences are as above given.

SECOND: The name of the proposed Corporation is GREENFIELDS AT COLLEGE PARK HOMEOWNERS ASSOCIATION, INC.

THIRD: The place at which it proposes to have its headquarters or be located is 1301 - 48th Avenue North Myrtle Beach, SC

FOURTH: The purpose of the said proposed Corporation is to administer the operation and management GreenFields at College Park Homeowners Association, Inc.

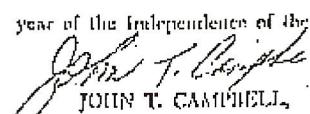
